### **Boarding Policies**

#### **Fees and Drop-off/Pick-Up**

Lodging charges will begin on the day of check-in until 3:00 pm the next calendar day. Regardless of drop-off time, the first day is charged for boarding. After the first day, if you check your pet out by 1:00 pm, no additional charge is incurred for that day. If you check your pet out between 1:00 and closing an additional charge of \$10.00 per pet applies for that day. Drop off and pick up times are during our regular business hours.

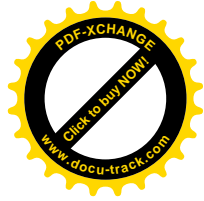
Please bring enough of your own pet food for your dog. If we run out of food Science Diet dog food will be given to your dog at a fee of \$1.00 per day.

#### **Vaccinations, Parasite Control, Medications**

For the safety of all our boarding pets, we **require** proof of current vaccinations **prior to** lodging. If proof cannot be provided **prior to** lodging, we cannot board your pet. **Fax pet records to 678-254-2081 or bring copies with you prior to boarding your pet.**

We also require all lodging pets to be free of internal and external parasites (fleas, ticks, lice, intestinal parasites). Any patient found to have any of these parasites will be treated at the owner's expense.



We will make every attempt to inform you before we do this so you will be aware of any extra charges, but if you cannot be reached, we will proceed with treatment. If your pet has any **prescription** medications that need to be given, there will be a small fee of \$2 per day for providing this service.

If we cannot contact anyone, we will bring them to your vet, the emergency vet or our vet, depending upon the time of day and/or your pet's condition. If our vet is closer than your vet, we reserve the right to take them there first. Our vet is Ark Veterinary Hospital on Friendship Road in Buford, GA.

Veterinary fees will be added to your invoice when applicable.
